Ownership Agreement

What is a co-op? A co-op is a business that is owned by its members. Those member-owners have a direct say in how the co-op operates.

When will the store open? That's up to all of us. A store location has been selected, and Co-op volunteers are now urgently raising funds for the purchase of the property and other immediate costs, while also working toward the membership goal of 1,500 by the time the store opens

Why become a member? While anyone can shop at the Pullman Good Food Co-op, owners receive specific benefits! Owners can direct the store through their voting rights, and can run to become a Co-op Board Member. Best of all, you gain a deep satisfaction knowing that you are making a positive impact in your local community!

To provide the community with equitable access to healthy, affordable, quality food, with a priority to support local producers.

By completing the Ownership Agreement and accepting ownership in the Pullman Good Food Co-op, I hereby certify that I have read carefully and agree to the following terms and conditions:

- I will abide by the Bylaws of the Co-op.
- I will provide the Co-op with a current physical mailing address.
- If my account is inactive as defined in the Bylaws, my ownership may be terminated.
- Owner cards issued in association with my ownership are provided solely for my use, for the use of my authorized domestic partner, and for my dependents under the age of 18. Owner cards issued to businesses are provided solely for the use of the business.
- The price of ownership and other Co-op policies may be changed as the need arises through a protocol outlined in the Co-op Bylaws.
- Patronage Dividends may be issued only to paid-in-full owners and will be issued at the discretion of the Board of Directors. I am liable for any taxes that may accrue for dividends I receive.
- My ownership is not transferable.

I have read and agree to comply with the Pullman Good Food Co-op Articles of Incorporation, Bylaws and Owner Agreement.
